ACS Community Fund Application Guidance Notes

Purpose

The purpose of these grants is to benefit the village and its residents.

- The use of the grants is to benefit the widest possible range of groups and activities, both existing and new.
- Applications may be submitted for an amount up to that specified for any purpose that will benefit the village and its residents.

Types of Grants

There are 3 types of grants.

- The three year grant
 Up to £500 per year for three years
- The one year grant
 Up to £500 for one year.
- A one year bursary for an individual Up to £500 for one year.

Eligibility

- Applicants should reside in, or be based within the Parish Boundary.
- Applications for the three and one year grants are open to clubs, societies, organisations, households and groups.
- The one year bursary is open to individuals. If the individual is under the age of 18 he/she must be supported by an adult or recognised group. On completion of an individual bursary ACS would be pleased to provide a reference or evidence of a successful outcome.
- Any group or individual may only apply for one grant per year.

Finance

- Funds may be requested for start up, equipment, running costs, expenses, advertising, training, health and safety. If other please specify in the application.
- Applications are not acceptable when judged to be for payment of salaries, political or commercial use.
- Receipts and records must be available on request.
- The recipient must have access to a bank account.
- For groups and societies, the applicant may be asked to provide their latest financial statement.

Process

- Complete the application form online or in hard copy and return electronically or hard copy as shown on the application form.
 - Please continue on the back of the form if more space is required.
- Where the applicant for a one year bursary is under the age of 18 he/she is encouraged to complete the application themselves.
- Applicants may be invited to meet the Grants Committee to discuss their application.
- All applicants will be informed of the outcome of their application.
- All decisions by the Trustees are final.

Reporting

- The applicant will be asked to provide a concise report at the end of the year. The report may include illustrations.
- For the three year projects, a short progress report will be requested annually.
- ACS reserve the right to publish the reports in their newsletter and in the Village Newsletter.
